VCI-605 is a powder corrosion inhibitor designed specifically as an admixture to deicing salt to prevent corrosion due to chlorides.

VCI-605 can also be used in closed loop cooling systems containing brine solutions at a concentration level of 0.3% to 0.5%.

VCI-605 contains vapor phase corrosion inhibitors capable of protecting surfaces not contacted by the brine solutions. It provides protection to ferrous and non-ferrous metals.

VCI-605 is non-toxic, environmentally friendly and contains no nitrite or phosphate inhibitors. VCI-605 is safe and economical to use.
