MCI®-2020 is a corrosion inhibitor formulated to migrate through the concrete, seeking out and attaching itself to the surface of reinforcing steel. Apply MCI® -2020 by low pressure spray or brush onto the prepared surface until it soaks into the concrete in a time frame of 7.5 - 24 hours.

Important: If overdose of MCI®-2020 occurs, it is necessary to rinse the concrete surface before application of MCI®-2026 Primer HS.

MCI®-2026 Primer HS

MCI®-2026 Primer HS is a water-based, 2-component, epoxy coating for concrete that outperforms and outlasts most solvent-based sealers without the associated odors, flammability, or VOC's. MCI®-2026 Primer HS meets all of the USDA guidelines for use in federally inspected poultry and meat plants. MCI®-2026 Primer HS is available in clear, gray and other colors. MCI®-2026 Primer HS can be used as a part of MCI®-2026 Flooring System or as a stand alone coating.

Important: Allow the MCI®-2026 Primer HS to dry before mixing and applying the next coating. The primed floor should be tack free and clear in appearance. This will vary with temperature and humidity but is normal between 2-5 hours at 75°F (24°C) and 50% R.H.

MCI®-2026 Floor Coating

MCI®-2026 Floor Coating is a 100% solids, 2-component, novolac epoxy coating designed for environments that require a high degree of chemical or temperature resistance. MCI®-2026 Floor Coating meets all of the USDA guidelines for use in federally inspected poultry and meat plants. MCI®-2026 Floor Coating is available in clear, gray and a selection of colors.
