VpCl® Chameleon™ is available in 5-gallon (19 L) pails, 55-gallon (208 L) drums, 275-gallon (1,040 L) totes, and bulk.

To ensure best product performance, store in original packaging, indoors, and out of direct sunlight at 40-100 °F (4-38 °C).

## **APPLICATION**

When used for boiler wet layup, the suggested dosage is 0.5% by volume. Calculate the amount of product needed for the total volume and add in a manner that ensures even mixing and distribution throughout the boiler. Seal the boiler for the duration of wet layup.
